- 1) For En-Primeur 2015 purchases, wines are scheduled for Mid 2018 release, delivered ex-Bordeaux, France.
- 2) Goods fully paid (upon Issue of Invoice), are rightfully the Property of the Buyers, under the custody of Vine Group PL.
- 3) Bottled Wines will be appropriately cellared either in Bordeaux, France or Singapore (Bonded Customs Facilitated Warehouse).
- 4) For Shipments to Singapore, an estimate S\$15.00 per 75cl bottle is applicable to cover shipping, insurance & handling. This does not include extraordinary Logistic Charges.
- 5) For wines delivered in Singapore, Excise Duty & GST charges applied would be based on the prevailing GST rates.
- 6) Upon Instruction from the Buyers, Vine Group PL would Broker and/or release the wines accordingly.
- 7) For Shipping via Reefer to Singapore, it would be in accordance to Vine Group Shipping Schedule (at least twice a year).
- 8) In the event of non-delivery of the physical stock due to unforeseen circumstance, the purchaser will be fully refunded.
